Fees - Provincial Grand Lodge Bye-Laws

17B Annual Dues by members through their respective Lodges is £5.00

17A Each Lodge in the Province shall make an annual payment of £100.00 with the addition of £5.00 for each candidate Initiated or Affiliated, to the funds of Provincial Grand Lodge for the defraying of expenses of Regalia, Meetings and other necessary purposes, and any Lodge in arrears of Annual Contribution and refusing to pay the same, shall have no right to be represented in Provincial Grand Lodge and shall also be liable to suspension.

17A (111) Each Lodge in the Province shall pay to Provincial Grand Lodge a further sum of £5.00 for each Candidate Initiated or Affiliated. The sums so received shall form a Benevolent Fund and be kept separate from the ordinary income of Provincial Grand Lodge. A return of the number of Candidates and Affiliates, a remittance of the sum due and a copy of the Annual Accounts shall be forwarded to Provincial Grand Secretary by each Lodge on or before the 31st January each year.
